- C. Programmes under the ambit of Regulatory Authorities have been considered on the basis of communication/recommendation received separately from respective Regulatory Authority. In case of approvals/recommendations received from Regulatory Authority, HEI shall abide the conditions such as number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.
- D. One chance will be given to the HEI for submitting Compliance/Clarification. If not complied, then the HEI can apply as afresh for next Academic Session.

Remarks:

- 1.*As per the recent decision made by AICTE to offer BBA, BCA and BMS Programmes, the approval of AICTE is mandatory from July, 2024 onwards. The HEI needs to obtain approval /NOC from AICTE to continue offer BCA, BBA & BMS Programmes in Online mode from July, 2024 onwards.
- 2.**Subject to the approval of AICTE on number of seats, valid academic year etc. mentioned in the relevant Regulatory Authority letter.
- 3. The HEI shall offer the programmes which are found complied at Table III for the academic year 2023-24, academic session beginning February, 2024 onwards.
